School Street Scheme - Abbey Primary School (Glastonbury Road)

Sutton Council is committed to making the streets outside our schools safer and healthier for our children. One way of doing this is to introduce School Streets. Sutton has successfully introduced 10 such schemes outside schools in 2021/22.

From ours and other boroughs' experiences, residents of School Streets experience lower volumes of traffic, fewer instances of inconsiderate parking and improved air quality from a reduction of engine idling.


A review of the 10 School Streets schemes in Sutton found:

Traffic volumes	Pedestrian numbers	Average cycle numbers	Average light goods vehicle numbers	Air quality

Reduced by over 50%	Increased by 24 %	Increased by 36%	Decreased by 40%	Improved by 33%

Due to the positive feedback from these initial schemes, we are now expanding the School Street programme and our next scheme is proposed for Abbey Primary School.

The school has been active in promoting walking, scooting and cycling and reducing car use at school run times. The school administration has expressed their support for a school street scheme to help further reduce car use and increase walking and scooting.

What are the details of the School Streets scheme?





Restriction point

The proposed temporary restriction is on Glastonbury Road between Hexham Road and Hartland Road. Roads will remain open to pedestrians, cyclists and those with exemptions.



Times of operation

The School Street scheme would operate Monday to Friday in term-time only and not at weekends or during school holidays. The proposed times of closure are **8.30am-9.15am** and **2.45pm-3.30pm**.



Enforcement measures

It is proposed that the scheme would be enforced with a static ANPR (automatic number plate recognition) camera.



Resident exemptions

It is proposed that you would be exempt from the restrictions, and be able to enter and leave during the restricted time, if you are a resident of the following addresses.

Vehicle movements

Any drivers permitted to enter the scheme will be asked to try and plan their arrivals and departures outside of the restriction times. This reduces the number of vehicles accessing the street while families are arriving at or leaving school and will help the scheme to operate more effectively (see enclosed leaflet for more detail on who can enter a School Street during hours of operation).



Monitoring

We are aware there may be concerns from residents outside of the School Streets boundary about displacement of parking as a result of any proposal and we will be carrying out traffic and parking monitoring surveys to assess any impacts of the scheme.
