

### **COUNCIL TAX – SINGLE PERSON DISCOUNT REVIEW**

We are in the process of reviewing current claims for Council Tax single person discounts. According to our records, you are currently receiving a 25% discount on your account because you are the only adult over 18 living at your property.

- We will shortly be performing further and more detailed checks on household residency in order to validate claims for Council Tax single person discount.
- These residency checks will be performed in conjunction with an external agency.

If you are no longer the only adult over 18 living at the property, please fill in the names and other details for all the other adults who now live in the property and complete the declaration below. Please see the guidance notes overleaf for details of adults who are not counted for Council Tax purposes.

We may cancel your discount from the date you first claimed it or it was last checked if you do not respond to this letter promptly. Even if you are in receipt of Council Tax Reduction you still need to respond.

Failure to complete and return the form may result in you losing your discount. You must send the form back, **even if you have recently given similar information to us**. Please return the form in the pre-paid envelope provided or to **Single Person Discount Review**, **PO Box 8028**, **Swadlincote**, **DE11 1FG**. This is the address of the agency who are carrying out this work in conjunction with the Council.

- 7. People aged 18 or 19 for whom Child Benefit is payable
- 8. People in detention
- 9. Severely mentally impaired
