## **Delayed Entry request - declaration**

- This is not an application form a Common Application Form (CAF) must be completed. The CAF will be available from 1st September the year before you wish your child to start.
- 2. In making a delayed application for primary school, there is no guarantee of the school which will be offered for September of the following year and we cannot guarantee one of your preferences will be met – the schools' usual admissions criteria will be applied to your application.
- 3. It is your responsibility to contact your existing nursery/pre-school provision (if applicable) to ensure a place remains available for your child.
- 4. A decision to agree your request does not apply to any future junior/secondary school applications or changes of school. Under the current guidance, you would need to make a new request for consideration at the relevant time.
- 5. If the child is issued with Educational Health and Care Plan, this would supersede any decision.
- 6. I understand the information I have provided will be shared with schools.
- 7. I have read the Privacy Notice https://cognus.org.uk/privacy/ and understand how my information may be used.
