Local update

Provider agreement

Provider agreements for childcare providers who wish to offer **any** free entitlement funding from September 2017 will be sent out shortly. Any provider who has not signed the agreement by September will no longer be able to claim any free entitlement funding until they have done so. Agreements will be sent electronically and can be return either electronically or by post.

Any provider who has not received free entitlement funding from the local authority previously will be required to complete additional forms.

Childcare works business planning training

30 hour preparation for September drop in support.

Parent declaration form for 3 & 4 year olds and checking eligibility for 30 hours

All provider should now have the new Parent declaration form for 3 & 4 year olds. If a parent has their '30 hour' code please ask the parent to complete the declaration form. Once the parent declaration form is completed, providers can contact the Family Information Service 020 8770 6000 to verify the code. Once the code is verified and eligibility for the 30 hours is confirmed, providers can offer their conditional places for September.

To note, parents will need to re confirm their eligibility every three months and in the event a family are no longer eligible for 30 hours the local authority will inform the provider of the grace period that applies.

Disability Access Funding (DAF)

DAF is a fixed lump sum of £615 per eligible child paid to the childcare provider where the child receives their free entitlement for 3 and 4 year olds. Children must be in receipt of Disability Living Allowance (DLA) to attract DAF funding.

Parents of children in receipt of DLA must complete the relevant section on the parent declaration form for DAF to be allocated.

DAF can only be allocated to one provider per year, in the event a child attends more than one setting the parent must choose which provision should receive the funding.

The local authority will collect the data and allocate funding in the **Autumn term** only around Headcount date.

Day nursery and pre-school managers meeting

Provider portal training

There will be provider portal training for all providers before September on the upgrade to the provider portal that will include how to confirm eligibility for 30 hours, EYPP and 2 Year old funding. Further details will be circulated shortly.

National update

Operational Guidance

The DfE have published an operational guidance to support the delivery of the 30 hours extended entitlement. The guidance can be found here. This document builds on the statutory guidance and is intended to support local authorities and providers understand in more detail the DfE's expectations about how the free entitlements should be delivered.

Eligibility Checking for 30 hours

The Childcare Service System has also now gone live for parents with children up to the age of 4. This means that parents wishing to access the 30 hours free childcare entitlement from September, will now be able to apply using the system. Childcare choices

<u>Childcare Choices</u> is a government website for parents, that brings together information on all the government childcare offers available, helping parents find the right childcare support. Parents will be able to check eligibility for 30 hours and sign up for tax free childcare using this websitesite.

Tax free childcare

Tax free childcare is a new scheme for working parents, that is similar to how the current employee voucher scheme works. Parents will need to create an online account and will be able to pay their childcare provider through this account. The childcare provider must also sign up to Tax free childcare to receive payment.

All providers should have by now, received information from HMRC on how to sign up to Tax free childcare.
