

Location

The property is situated on the Council's residential St Helier Estate. It adjoins elderly persons sheltered accommodation. It fronts Blake Close which is a small residential development built in 1990 at the same time as the property. Blake Close is an adopted road and there is on street parking available in the close, as well as 4 car spaces and a mini bus space at the property.

There are shops, health facilities, Library at the nearby Middleton Circle which is about 1/2 km away. Bus routes run along Green Wrythe Lane/Middleton Road.



An additional parcel of land may become available at a later date.
