Citation

1. This Order may be cited as the London Borough of Sutton Public Spaces Protection Orders 2020 (Various) (Extension) Order 2023.

Commencement

2. This Order shall come into force on 20 October 2023.


Extension of period various London Borough of Sutton Public Spaces Protection Orders 2020 have effect and duration.
