This first newsletter from the Council's Housing Regeneration team aims to bring everyone who lives on the estate up to date with consultations about the future of Elm Grove.

Over the past year the Council has been working with residents and Community Architect Levitt Bernstein to develop options for the regeneration of Elm Grove. Six consultation meetings have been held for residents to share views and opinions on how Elm Grove could be improved. We are grateful to those of you who have been able to give up your time to attend and contribute ideas to these meetings.

No final decisions have yet been taken about the future regeneration of Elm Grove.

Summary of the Council's offer

- Resident owners and Council secure tenants have the right to live on the new estate
- Tenancy conditions and rights will be preserved for existing secure tenants
- Your new home will be better designed, in a better environment and be more sustainable (eg easier to heat and maintain)
- 'Home loss' and disturbance payments (eg removal costs) will be made.

Housing Needs

The Council is committed to collaborating with residents to create new homes and communities to deliver more affordable homes for local people.

Since February we have held 'one to one' meetings with 80% of residents to hear your views, listen to your concerns and learn more about your circumstances, so that we can better understand your housing needs and preferences. If you haven't booked your 'one to one' meeting yet please contact Sabrina.

It is unlikely that any future regeneration proposal will be able to guarantee the full re-provision of existing houses and bungalows on the estate. Residents who live in these homes will naturally have concerns, as some have said they would prefer to continue living in a similar property. We will continue to look at all alternative housing options for these residents.

For Council secure tenants who urgently need to move, please ensure your housing register application is up to date. You can also contact us to discuss your individual circumstances.

Thinking of selling your home?

If you are a homeowner wishing to sell your property in advance of any regeneration scheme, the Council could purchase your property at open market value through the Council's 'buy-back' scheme. To find out more about this scheme please contact Sabrina.

Next Steps

Over the coming months we will:

- Complete this initial assessment of financial and planning implications
- Continue 'one to one' meetings with Elm Grove residents
- Set up an Elm Grove Residents' Steering Group
- Work with the 'Steering Group' to:
 - produce a Frequently Asked Questions leaflet
 - appoint an Independent Tenant and Homeowner Advisor
 - arrange site visits to other housing regeneration schemes
 - undertake a further review of the different options for the estate
 - develop the Residents' Charter (including details of the Council's offer)
