This newsletter is to update you on the future of Beech Tree Place.

The Future of Beech Tree Place

Over the past few months we've held several workshops to talk to residents about what options there are for the future of Beech Tree Place. From this we agreed to explore 3 options: (i) refurbishment, (ii) partial redevelopment & refurbishment and (iii) full redevelopment. We also agreed the draft Residents' Charter; detailing the council's offer and commitments to secure tenants of Beech Tree Place, and Community Charter; outlining the shared vision and priorities for the area.

Site Tour

In February we visited Oaks Court (Morden) and Peppermint Court (Wallington) so residents could see modern standards of housing for older people. Our architects had hoped to take residents to see some of their own schemes, however due to the lockdown this has not been possible. Instead Paul from HTA Design has prepared a brochure containing a range of examples of their refurbished, partial redevelopment and full redevelopment housing schemes. This brochure will be delivered to you soon.



Committee Approves Section 105 Consultation

On 30 March the Council's Strategy and Resources Committee considered a report about the Future of Beech Tree Place and agreed for officers to formally consult secure tenants on the 3 options and the Residents' and Community Charters. Over the coming weeks we plan to start the consultation by sending you a letter and 'Consultation Pack' containing all the information you need. This will include a feedback form for you to complete and return to us. Once the options and feedback have been assessed, we'll report back and take our recommendations to a future Committee meeting for a decision on which proposal should be adopted.

Decision on the Architect

When the Council appointed Savills as its Commercial Adviser in October, their team included architects HTA Design, who specialise in sustainable housing, regeneration and resident engagement. The Residents Steering Group (RSG) agreed to work with HTA on the options for the estate and then decide on whether to continue this arrangement or hold a separate competition to appoint an architect to take forward a chosen option. We are now at the stage where residents need to make this decision.
