## **1. Introduction**

- 1.1** As a Local Planning Authority, the Council has a statutory duty to prepare, monitor and review the council's planning policy documents. Under Section 15 of the Planning and Compulsory Purchase Act 2004 (as amended), the council is also required to set out the council's current planning policy documents and any new or replacement documents that the council intends to produce in the future. It is required to do this in its Local Development Scheme.
- 1.2** The previous Local Development Scheme covered the period 1<sup>st</sup> April 2018 to 31<sup>st</sup> March 2023. However, under regulation 10A of The Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended) local planning authorities must review local plans, and Statements of Community Involvement at least once every 5 years from their adoption date to ensure that policies remain relevant and effectively address the needs of the local community.
- 1.3** Where a review was undertaken prior to publication of the Framework (27 July 2018) but within the last 5 years, then that plan will continue to constitute the up-to-date plan policies unless there have been significant changes. Local housing need will be considered to have changed significantly where a plan has been adopted prior to the standard method being implemented.
- 1.4** As the Sutton Local Plan was adopted in February 2018, i.e. prior to the introduction of the standard method, Council has decided to commence evidence gather to support a review of its Local Plan. However, the Queen's Speech in May 2021 confirmed that the government is progressing with the further fundamental changes to the planning system that were proposed in 2020 white paper 'Planning for the future'. As such this timetable could be subject to changes, depending on the content and timing of new legislations. Any changes will be reflected in an updated LDS.

## **2. The Context for the Local Development Scheme**

- 2.1** This Local Development Scheme sets out:
- the details for the Development Plan Documents (DPDs) to be prepared
  - the details of the Supplementary Planning Documents (SPDs), which the council considers are necessary to inform Local Plan policy implementation on the council's planning priorities

## **3. The Current Development Plan**

- 3.1** The Council's current Development Plan comprises:
- The London Plan 2021
  - The Local Plan DPD (adopted 2018)
  - The South London Waste Plan DPD (produced in conjunction with the London Borough of Croydon, the London Borough of Merton and the Royal Borough of Kingston, adopted 2012); and,

- The Policies Map, which is a map-based expression of the policies in the Local Plan and South London Waste Plan, adopted 2018)

3.2 The Local Plan DPD and South London Waste Plan DPD were both prepared according to statutory requirements and were subject to an Examination-in-Public before a Planning Inspector. The Council's decisions on planning applications should be taken in line with these documents unless material considerations indicate otherwise.

#### 4. **New Development Plan Documents to be Prepared**

4.1 Over the time period of the Local Development Scheme, the council intends to produce two DPDs:

- The Sutton Local Plan (Reference: DPD1), to provide the spatial vision, strategic objectives, policies and allocations for the London Borough of Sutton between 2023 and 2038
- South London Waste Plan (Reference DPD2), which replace the current South London Waste Plan which expires in 2021. This is a joint DPD with the London Borough of Croydon, the Royal Borough of Kingston and the London Borough of Merton

4.2 See tables DPD1 and DPD 2 (below) for how and when these DPDs will be produced.

#### 5. **Current Supplementary Planning Documents**

5.1 SPDs are not part of the Development Plan and so do not have the same weight in planning decisions. They are intended to provide more detailed advice on how planning policies should be implemented or how site allocations should be developed. A list of the adopted SPDs as of 31 March 2021 can be found in Table 1 below.

#### 6. **New Supplementary Planning Documents to be Prepared**

6.1 The council will produce the following SPDs within the time period of this Local Development Scheme:

- Urban Design Guide (Reference SPD1), which will express the council's commitment to well-designed developments and will update and replace the Designing Out Crime SPD, the Design of Residential Extensions SPD and the current Urban Design Guide SPD;

6.2 See tables SPD1 (below) for how and when this SPD will be produced.

### **Community Infrastructure Levy**

6.2 The council adopted its Community Infrastructure Levy (CIL) in March 2014 and it came into force on 1 April 2014. Details of the Community Infrastructure Levy and the Planning Obligations SPD, which was revised alongside it, can be found at: <https://www.sutton.gov.uk/cil>. The council will review its Regulation 123 List (the schemes which it spend CIL receipts on) and its CIL Charging Schedule but it is not required to provide timetables for these revisions in the Local Development Scheme.

## **7. Neighbourhood Plans**

7.1 The council has designated three neighbourhood forums and areas, which are in the process of producing neighbourhood plans:

- The [Hackbridge and Beddington Corner Neighbourhood Plan](#) made in October 2018, covering the period 2017 to 2027.
- The Beddington North Neighbourhood Forum, which was redesignated in 2018, is producing the Beddington North Neighbourhood Plan; and,
- The Belmont and South Cheam Neighbourhood Forum, which was designated in 2016, is producing the Belmont and South Cheam Neighbourhood Plan. It is expected that consultation will be carried out in 2021.

## **8. Article 4 Directions**

8.1 Article 4 Directions withdraw permitted development rights, requiring a planning application instead. The council has three Article 4 Directions in force:

- The Sutton Garden Suburb Article 4 Direction, which removes permitted development rights for certain properties in the Sutton Garden Suburb Conservation Area;
- The Sutton Town Centre Article 4 Direction, which removes the permitted development right for offices to convert to residential uses; and,
- The Roof Alteration Article 4 Direction, which removes the permitted development right to alter roofs for certain properties across the borough.

9.3 The Council has no plans to make any further Article 4 Directions during the lifetime of this Local Development Scheme.

## **10 Conservation Area Appraisals and Management Plans**

- 10.1** Whenever possible, the Council will produce Conservation Area Character Appraisals, which identify the special features of a Conservation Area, and Conservation Area Management Plans, which set out how those special features will be conserved and enhanced. These documents are not formally adopted but are usually approved by a council committee. They form an important source of information when planning applications are decided in Conservation Areas.
- 10.2** Currently, the council has the following Conservation Area Appraisals and Management Plans in place:
- Sutton Garden Suburb Conservation Area Character Appraisal;
  - Sutton Garden Suburb Conservation Area Management Plan;
  - Wallington Green Conservation Area Character Appraisal;
  - Wallington Green Conservation Area Management Plan;
  - Carshalton Village Conservation Area Character Appraisal and Management Plan; and,
  - Sutton Town Centre Conservation Area and Management Plan Character Appraisal
  - Beddington Village Conservation Area Character Appraisal
- 10.3** In addition, the Council has consulted on the following conservation areas
- Draft Cheam Village Conservation Area character Appraisal and Management Plan
  - Draft Beddington Parks (including Carew Manor Conservation Area and Church Lane Conservation Area) Conservation Area Character Appraisal and Management Plan
  - Draft Wrythe Green Conservation Ara Character Appraisal and Management Plan.
- 10.4** The Council will attempt to produce more character appraisals and management plans during the time period of the Local Development Scheme.

## **11 Monitoring and Review**

- 11.1** The council will monitor the progress of the work set out in this Local Development Scheme and will publish the results in its monitoring reports. This Local Development Scheme will be updated or reviewed if there is a need to do so.

## DPD1: Sutton Local Plan and Policies Map 2023

### Role, Content and Purpose

To provide the spatial vision and strategic objectives for the London Borough of Sutton between 2023 and 2038. The Local Plan will also provide more detailed policies against which the council will determine planning applications. The Local Plan will also allocate sites for development or redevelopment in order to ensure its spatial vision and strategic objectives are achieved. This will also involve the preparation and publication of a new Policies Map, the map-based expression of Local Plan policies, site allocations and designations. The document will replace the currently adopted Local Plan DPD (2018).

To safeguard sites for waste treatment (if required) and/or to identify areas suitable for waste treatment facilities (if required). The document will replace the South London Waste Plan 2011-2021.

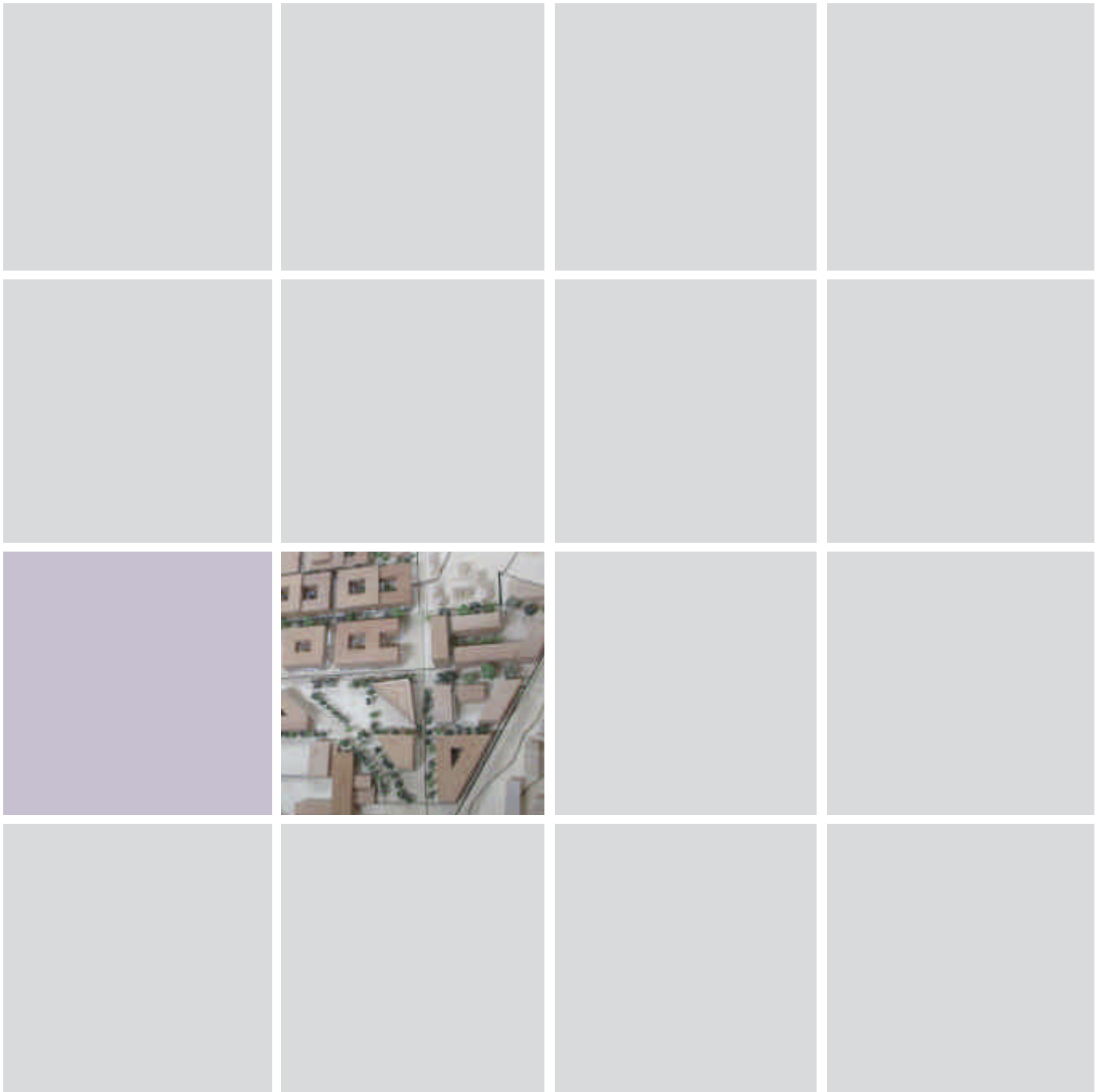

**13.1** The Table below sets out the changes that have been made the LDS 2018 to 2023, and which have been incorporated into this LDS.

<b>Document</b>	<b>Amendments</b>
DPD1: Sutton Estates Area Action Plan	<p>Following adoption of the Local Plan, the council has been investigating the feasibility and viability of estate regeneration in and around Sutton town Centre, and subject to the above, prepare an area action plan DPD.</p> <p>However, if a Local Plan review now a requirement, the Council will now consider how estate regeneration can be supported through a new Local Plan, instead of the preparation of a separate DPD. This work is still subject to ongoing considerations regarding viability and feasibility.</p>
DPD3: Gypsy and Traveller Plan	<p>The Local Plan 2018 included a requirement to reassess Gypsy and Traveller need by 2023 and, if necessary based on the evidence, to prepare a Gypsy and Traveller DPD.</p> <p>However, as the Council needs to review its Local Plan, and the timescales are aligned with the above requirement, the Council will address Gypsy and Traveller need through the Local Plan review.</p>
