A message from the Leader



Dear resident,

I have been the Leader of the London Borough of Sutton for nearly 12 years and there has not been a time when the financial crisis faced by the Council was as great as the one we see now.

Across the UK all councils are having to deal with the consequences of years of government underfunding, increased demands for our services and rising costs.

Here in Sutton, the amount the Council receives in funding from central government has been slashed and yet the number of adults and children requiring our care has risen hugely while the costs of providing this care has reached record levels. Along with the increase in the number of people who are finding themselves homeless, our budget is being stretched to its limit.

Most of our funding comes from our council tax and in order to continue to provide vital services, the government has assumed councils will pay for our increased costs by taxing our residents. So we have been left with no choice but to take the difficult decision to increase council tax.

This means the average Sutton household living in a Band D property will pay an extra £1.55 per week in council tax as well as an extra £0.72 per week for the Greater London Authority (Mayor of London) charge. This is a total increase of £2.27 per week.

I know that this council tax increase comes at a particularly hard time for many people and in this booklet you can find services that can help. As we take the decision to increase council tax, I can promise that we will continue to be a council that uses your money wisely and well. Since 2011 the Council's rigorous savings programme has seen us save over £118 million and most recently the Council has implemented programmes that will reduce the size of the Council's workforce, while still continuing to provide those 800 services that we depend on.

Over the next year, with demands on our services showing no sign of reducing and with a further £10.6 million in savings we need to find, our budget remains under pressure.

In response to this, the Council is changing the way we do things. As part of our change programme, the Council will be seeking your views on the services we can afford to provide and I really encourage you to get involved.

Alongside this programme of change, we will also continue to manage the careful investments we have made that will benefit everyone living and working in our borough. For example, the London Cancer Hub in Belmont will bring thousands of new jobs; our plans to regenerate the town centre will provide better work and leisure opportunities, protect our shops and create new jobs, and we will ensure that over 500 new affordable homes are built over the next five years to provide the housing that so many people desperately need.

Despite these challenging times ahead, I am confident that together we will build on the strength of our local communities and ensure that Sutton continues to be a great place to live, work and raise a family.





Our 2024/25 budget

Where our funding comes from

Like all local authorities, Sutton Council gets its funding from a range of sources including council tax, business rates, government grants, as well as fees and charges.





Rising demand for our services means that each week, we spend:



Over £1m on adult social care



Average of £250,000

on home-to-school transport for SEND pupils




Average of £7,000

on a child in residential care



Over £84,000

on emergency housing for more than 400 households



What does each Council department do?

People's Services includes adult social care and supporting children.

Public Health and Wellbeing includes school nurses, libraries and museums, leisure centres, Sutton College, sexual health, substance support, transport for older people and Meals on Wheels.

Environment, Housing and Neighbourhoods includes parks and open spaces, waste management, sustainability, roads, transport, housing regeneration, community safety, building planning and control, trading standards and emergency planning.

Development, Growth and Regeneration includes economic growth, Sutton Town Centre regeneration, creating The London Cancer Hub, employment and skills. This department has successfully brought millions of pounds of outside investment into the borough to deliver these projects.

Resources includes buildings, human resources, IT, finance, legal, elections, communications and policy.

How we calculate your council tax

As in all London boroughs, your total council tax is made up of two parts:

- An amount set by the Council based on how much money we need to deliver vital local services and meet our levying obligations (see below).
- An amount set separately by the Greater London Authority, called the GLA precept.

What are levies?

The Council Tax you pay includes amounts collected on behalf of other statutory bodies, known as levying bodies. These bodies pay for the net cost of their services by issuing a levy on each billing authority in their area, after deducting all other sources of income raised. The money due is included in your Council Tax bill, and is paid over to each body during the year.

Unlike the Greater London Authority (GLA) precept, levies have to be included as part of the council's own budget calculations and hence are included in the calculation of the Council's own band D tax. The amounts included are shown in the tables below:

What is the GLA precept?

The GLA precept is the part of your council tax that goes towards funding services provided by the Greater London Authority. These include London-wide transport, policing and fire services. The GLA precept is set each year by the Mayor of London, is collected by the Council and transferred to the Mayor. More information about the GLA precept is available at **sutton.gov.uk/counciltax** We calculate the Sutton Council element of your council tax in two stages. First, we work out how much money the Council needs to deliver its services and meet its levying obligations (our gross expenditure). Then, we work out how much income we will generate and other funding we will receive (our gross income). Then, we work out the difference (our net expenditure) and what we need to raise in council tax. The next two tables show these calculations for 2024/25. Figures in brackets show income, savings or a surplus.

 This table shows how much funding is needed to deliver council services, by department, and the ring-fenced central government grants we receive towards this. Ring-fenced grants are grants that must be spent on certain services and cannot be spent elsewhere.

How much council tax you will pay this year

How much council tax you pay depends on how much your home was worth in April 1991, when it was valued and put into one of eight bands by the Valuation Office Agency. Your council tax bill tells you which band your home is in. The table below shows how much council tax each band will pay in 2024/25.

Discounts and reductions

Depending on your income and who is living in your home, you may be able to apply for a discount on your council tax bill.

Council tax discounts

You may be eligible for a discount if you live alone (excluding any children under 18) or if you or someone you live with:

- Has a disability and your home has been adapted to meet their needs.
- Is a full-time student, student nurse, apprentice or Youth Training trainee.
- Is severely mentally impaired.
- Is a person caring for someone who is not their spouse, partner or child under 18.

Council Tax Reduction scheme

If you are on a low income or receive benefits, you may be eligible for a reduction on your council tax bill. Find out more at **sutton.gov.uk/counciltaxreduction**

Important information

Some discounts and exemptions are time-limited and will expire during the financial year. If your discount or exemption expires, we will send you a revised bill for the rest of the year. If your bill shows a discount or exemption that you are no longer entitled to, or your circumstances change so you are no longer entitled to a discount or exemption, you must tell us within 21 days. If you don't, you may have to pay a penalty.

Empty properties and exemptions

Empty and unfurnished properties, including those needing or undergoing major repairs or structural alterations, are not exempt from council tax. This follows a change in the law on 1 April 2013.

Properties that are empty (vacant and substantially unfurnished) for one year or more are subject to a premium. From 1 April 2024, the following premiums apply:

- For properties that have been empty for one or more years, but less than five years, the premium is 100%. This means you will be asked to pay 200% of the full council tax bill. (Prior to 1 April 2024 the property could be empty for 2 years before the premium became payable).
- For properties that have been empty for five or more years, but less than 10 years, the premium is 200%. This means you will be asked to pay 300% of the full council tax bill.
- For properties that have been empty for 10 years or more, the premium is 300%. This means you will be asked to pay 400% of the full council tax bill.

If a premium becomes payable during the financial year, you will be sent a revised bill.

As this premium applies to the property, a change of ownership or tenancy will not affect the premium. If the property had already been empty or substantially unfurnished for one or more years when you bought or leased it, you will have to pay the extra council tax.

Some properties are still eligible for an exemption.

Help to pay and financial support

The cost of living crisis is affecting many people in Sutton. If you are worried about paying your council tax or other bills, help is available.

Hardship Fund and Discretionary Housing Payment (DHP)

If you are entitled to a Council Tax Reduction, Universal Credit or Housing Benefit and are struggling with council tax or rent, you can apply for a Hardship Fund payment for council tax or a Discretionary Housing Payment (DHP) for rent.

These payments are designed for those who most need some extra help. Our budget is limited and we will prioritise helping to keep people in work and helping disabled and vulnerable people. We will also take levels of income and expenditure into account. Find out more at **sutton.gov.uk/DHP**


