Neighbourhood Fund 2024 Application Guide



What is the Neighbourhood Fund?

The Neighbourhood Fund is a portion of the Community Infrastructure Levy (CIL). We collect CIL on new developments in the borough and use these funds to support projects which help to address the demands which development places on local areas.

It is important that we consider the priorities of local communities when we are funding projects. Proposed projects will go through an eligibility check. Then we will publish a shortlist of projects through our annual Neighbourhood Fund consultation. This will help us judge the level of support for each project.

Projects will also be judged on other criteria, such as how well they align with Sutton's strategic priorities.

Who can apply?

In short, any groups with a community interest can apply. That includes local charities and organisations, residents' associations, and volunteer groups. If you are applying as an individual or a group which lacks a formal constitution, we may be able to work with Community Action Sutton or LBS service departments to hold the funds for the project on your behalf.

How much can I apply for?

The funding available to bid for will depend on how much we have collected from developments in the area the project is helping. We will provide advice about this as part of the initial eligibility check. Projects will be competing for funding, so more expensive projects will also likely need to promise greater benefit to local communities.

Projects must help to address the demands that development places on an area and align with Sutton's strategic aims and priorities

Further considerations for judging project submissions



- a. Does the project offer a demonstrable benefit for a wide range of residents?
 - b. Does the project offer good value for money?
 - c. Does the project avoid further financial costs to the council or provide savings?
 - d. Is there match funding available for the project?
 - e. Is the project in an area of higher deprivation?
- f. If the project is in an area covered by a Neighbourhood Plan, does it align with that plan?

Alongside the application form you may need to submit additional material to move the application forward or support the funding bid. Examples of material that we might ask for are:

- Photos/plans/weblinks for the proposal
- Any licenses or permissions that might be required (Planning Permission, etc.)
- 3 quotes for the project (if 3 quotes cannot be provided we will need to record the reasons why)
- Details of any crowdfunding or other match funding
- Details of how any ongoing costs will be met
- Results of any local consultation or evidence of support or need

Shortlisted projects - next steps



At the end of the public consultation period, we will recommend projects for approval or refusal and obtain feedback from local councillors and council services. Once the final approvals have been signed off we will contact applicants informing them of the decision.

- We will arrange to have a meeting with the successful applicants to discuss their projects.
- If an applicant is handling the funds themselves, they will sign a Funding Agreement before funding is released.
- Once the project is underway we ask that applicants keep in touch periodically with progress
 updates and photos. We will use these to update our online project pages.
- Finally, applicants must submit a report within 2 months of the project being completed. This
 should include documentation to allow us to track the use of the funding, including invoices,
 receipts and any final photos or progress reports.

A condition is included in the Funding Agreement that we may use reports and photos of the funded activities for the purpose of promoting the Neighbourhood Fund.
