PPCR appointed as Independent Tenant & Homeowner Adviser for Elm Grove

Last month a few members of the Resident Steering Group (RSG) in collaboration with officers from the Housing Regeneration team worked together to appoint an Independent Tenant & Homeowner Adviser (ITHA) for Elm Grove. Together we evaluated 5 written tenders and interviewed 5 experienced Resident Advisers before selecting Public Participation Consultation and Research Associates Limited (PPCR) as your ITHA.

As the ITHA for Elm Grove, PPCR will:

- Provide you with independent advice and support to represent your views and interests
- Help residents and resident groups to get involved in shaping future proposals
- Provide clear advice on council proposals and commitments, as well as any legislation
- Offer support in negotiating with the council
- Provide access to specialist financial, legal and property advice
- Offer training so you can take part in and contribute to discussions
- Work towards appointing a Chair for Elm Grove RSG

PPCR will be circulating a newsletter to introduce themselves, and we've arranged two virtual meetings to meet their team. The first meeting will be on 6 October 2020, 7pm to 8.30pm for RSG members only, followed by an 'All Residents' only' meeting on 14 October 2020, 7pm to 8pm. You will be able to join the meetings virtually or dial in using your telephone, please send us your contact details to receive the joining instructions.

What's next?

As we move forward in collaboration with residents, we've re-engaged your Community Architect Levitt Bernstein and jointly appointed **PPCR** as your Independent Adviser to work with us to explore estate options, review the Elm Grove masterplan and develop the councils Offer to residents through a local Residents' Charter. To facilitate this we plan to host a number of virtual meetings and workshops over the coming months. More details about when these will take place will be shared closer to the time, although we're aiming to start workshops in November.

Market House Community Hub

The refurbishment of the former RBS building has been delayed slightly, and we expected works to be completed by 16th October.

Hannah and Kieron from Sound Lounge, who are one of the tenants at the new Hub, are offering an opportunity for 18 - 24 year olds to gain a City & Guilds qualification in carpentry, labouring and painting & decorating; by working on the 'fit out' of the ground floor.
