

## COUNCIL TAX – RELIGIOUS COMMUNITIES

You have indicated that a resident at the above address belongs to a religious community.

Members of religious communities, whose principal concern is prayer, contemplation, education or the relief of suffering, may be disregarded for Council Tax purposes.

To qualify to be disregarded, the individual cannot have any income or capital, unless it comes from a pension received in respect of a former occupation. The applicant must also be reliant upon the community for his or her needs.

A questionnaire is enclosed for your completion and return to this office.

The Information is required in order to assess whether or not a discount is applicable. On receipt of the completed questionnaire it is possible that further information may be required.

Please note that until the completed questionnaire is received no discount will be considered. Should you require any further information or assistance, please contact the Council's Customer Service Team.
